**RELEASE OF LIABILITY, WAIVER OF CLAIMS, EXPRESS  
ASSUMPTION OF RISKS, AND HOLD HARMLESS AGREEMENT**

I, \_\_\_\_\_, for myself and my estate, heirs, administrators, executors, and assigns, hereby release and hold harmless Sarasota Paradise, from any and all liability and responsibility whatsoever, however caused, for any and all damages, claims, or causes of action that I, my estate, heirs, administrators, executors, or assigns may have for any loss, illness, personal injuries included, but not limited, to sprains, strains, contusions, concussions, fractures, knee injuries, neck injuries, back injuries, death, or property damage arising out of, connected with, or in any manner pertaining to the **U-20 Talent ID Camp**, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES or others, and assume full responsibility for my participation.

I fully understand that there are potential risks associated with my participation in the **U-20 Talent ID Camp** activity, including, but not limited to, possible injury or loss of life. Despite the potential hazards associated with the activity, I wish to proceed, and freely accept and assume all risks, dangers, and hazards that may arise from my participation in the **U-20 Talent ID Camp** activity and that could result in loss, illness, personal injury, death, or property damage to me or to my property. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others.

I further agree to indemnify and hold harmless the Releasees from any judgment, settlement, loss, liability, damage, or costs, including court costs and attorney fees for both the trial and appellate levels that Releasees may incur as a proximate result of any negligent or deliberate act or omission on my part during my participation in the on-court activity, to the fullest extent permitted by law.

In signing this agreement, I acknowledge and represent that I have read and understand it; that I sign it voluntarily and for full and adequate consideration, fully intending to be bound by the same; and that I am at least eighteen (18) years of age, or a parent or guardian of the player and willingly agree to comply with the stated and customary terms and conditions for participation in the **U-20 Talent ID**. I will participate in a safe and reasonable manner and if I observe any unusually significant hazards during my presence or participation, I will remove myself from participation and bring such hazard to the immediate attention of the nearest Sarasota Paradise official.

I hereby grant Sarasota Paradise, its affiliates, representatives, and media partners the irrevocable right and permission to photograph, record, or otherwise capture my image, likeness, voice, and/or performance during participation in the **U-20 Talent ID**. I authorize the club to use, reproduce, publish, distribute, and display such media, in whole or in part, for any lawful purpose including, but not limited to, publicity, social media, promotional materials, advertising, and other marketing or commercial uses, without further notice or compensation to me.
